# AZ NATP 2023 Tax Update

## **Course Descriptions**

<u>I've got Ethics</u>: Welcome back to Imagination Land Tax Services where The Old Woman in the Shoe has her taxes done. We will travel down the trail of ethics and compliance exploring more twists and turns with Old Woman, her extensive family, and new friends. **2023 IRS Federal Tax Update:** Each year the AZ Chapter of NATP presents the latest updates on tax laws and issues, but this year it is expanded to include 4 hours of federal tax updates. Topics will include the latest on 1099-Ks, K-2 and K-3 reporting, Corporate Transparency Act, energy credits, and much more.

Tax Issues for Married Filing Separately: As tax professionals, we know that marital status (and residency) affects filing status and that married taxpayers may choose between married filing jointly and married filing separately. However, depending on where they live (i.e., a community property state vs. a common law state), they may not have as many choices on how to split the income and expenses. Tax benefits may also be reduced if filing separately. We will determine the taxpayer's marital status, their most advantageous filing status, and evaluate various income sources and tax benefits.

<u>2023 Arizona Tax Update:</u> The AZ NATP Tax Update seminar is one of only a handful of workshops where Arizona Tax Topics are presented by tax practitioners. We will review legislative changes including updates to Pass-Thru Entity (PTE) and Small Business Income (SBI) taxes, the new AZ Families Tax Rebate, adoption expenses, applicable property tax laws and more!
